

CardScan Sweepstakes

Official Rules

PLEASE READ THESE OFFICIAL RULES CAREFULLY. BY SUBMITTING AN ENTRY FOR THIS SWEEPSTAKES, YOU AGREE TO ABIDE BY THESE RULES. THIS IS A LEGALLY BINDING CONTRACT BETWEEN YOU AND CARDSCAN, A NEWELL RUBBERMAID COMPANY (THE "SPONSOR").
